#### What information we collect, use, and why

### Lawful bases and data protection rights

We carefully balance our marketing activities with the individuals' right to privacy by limiting the use of personal data only to relevant communications. Our lawful bases for collecting or using personal information to comply with legal requirements:

#### Where we get personal information from

- Directly from you
- CCTV footage or other recordings
- Publicly available sources
- Previous employment
- Suppliers and service providers

#### How long we keep information

We retain personal information for as long as necessary to fulfill the purposes for which it was collected, including to comply with legal, accounting, or reporting requirements. This is normally for 7 years or until you withdraw your consent.

**Client Project Data**: We retain project-related personal information for the duration of the project and up to 7 years after project completion. This retention period allows us to reference past work, address any follow-up inquiries, or comply with legal obligations.

**Financial Records**: Personal information related to invoicing and payments, such as billing information, is retained for 7 years, in line with tax and financial regulations.

**Marketing and Communication Data**: We retain personal information for marketing purposes (such as email addresses) until a client opts out or withdraws their consent, or for up to 3 years after the last interaction.



**Legal Compliance and Dispute Resolution**: In cases where legal action or disputes arise, personal data may be retained until the matter is fully resolved and for the relevant statutory limitation period.

**General Contact Information**: For clients with whom we have ongoing relationships, we may retain personal contact information indefinitely, unless we are requested to delete it or the data is no longer relevant.

#### Who we share information with

#### Data processors

**IT and Secure Cloud Service Providers (UK / EU)**: Companies that provide cloud storage, IT support, or other digital infrastructure services (e.g., cloud storage for files or email hosting).

**Subcontractors and Freelancers**: Individuals or firms working on specific aspects of your projects who may need access to personal information to fulfill their tasks.

Accounting or Payroll Services: External firms managing financial transactions, invoicing, or payroll, which may need client contact details for billing or financial purposes.

**Marketing and Communication Providers:** Third-party companies providing marketing services, such as email marketing platforms, used for client communication and updates.

**Legal and Compliance Advisors:** Third-party companies providing marketing services, such as email marketing platforms, used for client communication and updates.

#### Sharing information outside the UK

Your information will be primarily collected and processed in the UK. Where necessary, we may transfer personal information outside of the UK.
